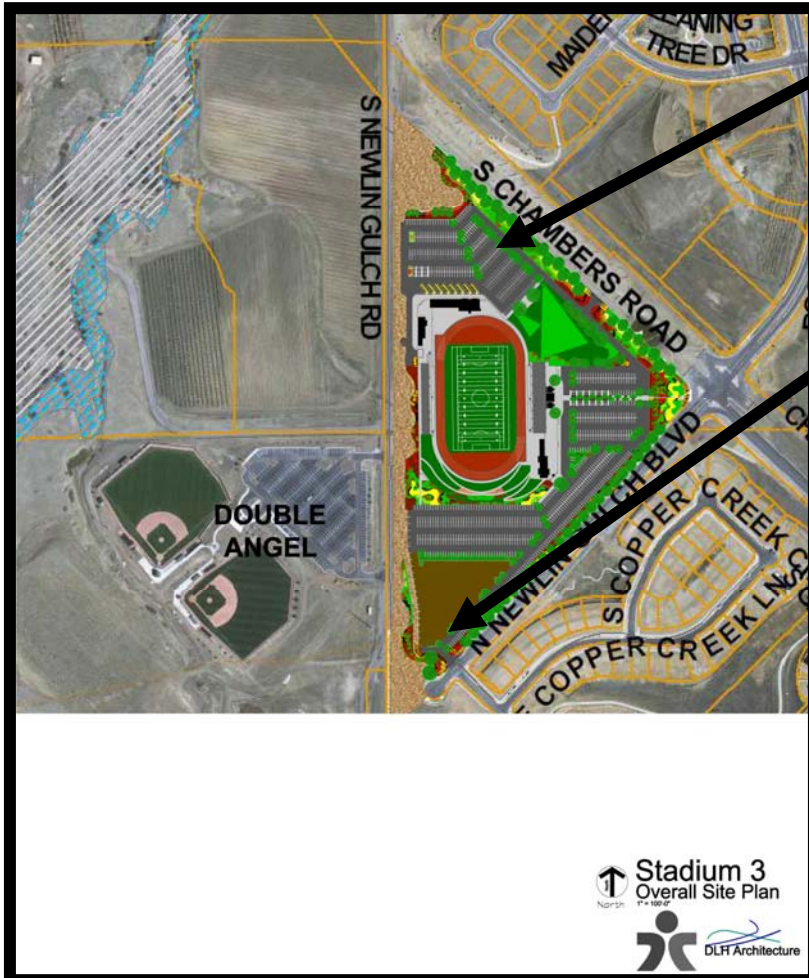

The Douglas County School District wants all spectators to have a safe and enjoyable experience while at an event at Burt.com Stadium. The following information is designed to be practical and functional and to allow for the safety of our students, spectators and staff.



Team Bus Entrances

Overflow parking

Entrance off of Chambers Rd.

From the north – Lincoln; south on Chambers Rd.; east on Main St.; south on N. Newlin Gulch Blvd; west on Chambers Rd.; Entrance on the left.

From the south – Parker (Highway 83) to Hess; west on Hess; north (right) on Chambers through the light at Newlin Gulch; entrance is on the left.

Main Entrance & Parking

Entrance is at the south end of the stadium off of N. Newlin Gulch Blvd.

From the north – Lincoln, south on Chambers Rd.; east on Main St.; south on N. Newlin Gulch Blvd; Entrance is on the right.

From the south – Parker (Highway 83) to Hess; west on Hess; north (right) on Chambers; south (left) on N. Newlin Gulch; entrance is on the right.

Handicapped Parking

Designated parking for those with parking permits is located immediately in front of the stadium press box area and can be accessed from either entrance.

Ticketing

Ticketing is at the press box on east side with entrances to the stadium immediately adjacent.

Student Activity passes will be accepted at the gate just south of the press box.

General Seating

VISITOR – Visitor seating will be on the NORTH SIDE of the EAST stands.

HOME- Home seating will be on the SOUTH SIDE of the EAST stands.

Container Policy

School officials may ask you to open backpacks for visual inspections. This policy is for the safety of our fans, student athletes and event staff.

TURF AREAS- All turf areas around the stadium are off limits to all spectators. Please stay in the designated seating areas during events.

Douglas County School District Spectator Expectations

We ask that our spectators stand for the highest standards of personal behavior. Regulations of the Colorado High School Activities Association (CHSAA) and the Douglas County Schools will be strictly enforced. Remember that you are at a contest to support and yell for your team and enjoy the skills and competition; not to intimidate or ridicule the other team, its fans or officials. The stadium and grounds is a Douglas County School facility and smoking is prohibited.

Concessions

Two concession areas are located on the east side of the stadium. Proceeds directly benefit the high school programs. Douglas County has worked to convert nearly all food and beverage containers in Burt.com Stadium to recyclable or compostable materials. Please note the abundance of collection containers for recyclable materials.
